1. PAGE ONE - NOTICE INVITING BIDS:

PURPOSE: **Change** bid acceptance deadline date from “Wednesday, August 1, 2012” to “Monday, August 6, 2012”.

2. PAGE ONE - NOTICE INVITING BIDS:

DESCRIPTION OF WORK, #1: **Add** “existing cedar shakes removed from the Chilkat Center can be disposed of at the Borough brush refuse site on Mud Bay Road near Carr’s Cove. **Only cedar shakes** can be dumped and hauling will be at the contractor’s expense.”

3. PAGE THREE - NOTICE INVITING BIDS:

Below REQUIRED SUBMITTALS: **Add** the following:

BID SUBMISSION: The Bid shall be delivered by the time and to the place stipulated. It is the Bidder’s sole responsibility to see that its Bid is received in proper time. Oral, telegraphic, telephonic, electronic, or faxed Bids will not be considered.

BID MODIFICATIONS: Bids previously sent by mail or other delivery method may be modified by facsimile up to 12:00 noon Local Time, Monday, August 6, 2012 provided that modifications do not state total bid but only the amount to modify the bid in the sealed envelope. Any Bid may be withdrawn prior to the above scheduled time for the opening of bids or authorized postponement thereof. No bidder may withdraw a bid within 30 days after the actual date of the opening thereof. Should there be reasons why the contract cannot be awarded within the specified period; the time may be extended by mutual agreement between the Borough and the successful bidder.

OWNER’S RIGHTS RESERVED: The owner reserves the right to reject any or all bids, to waive any informality in a bid, and to make award to the lowest responsible bidder as it may best serve the interests of the Borough.
