Routine maintenance includes but is not limited to: Change engine oil and filter, tire mount and balance, break inspection, belt inspection, drain water separators, etc. Please make sure that the charges for routine maintenance include both the hourly rate and the estimated time.
- 3) Routine maintenance will be scheduled within 10 business days of request by the Haines Borough and completed within 15 business days of request by the Haines Borough.
- 4) Contractor shall maintain sufficient insurance to cover all activities associated with the contract, including damage to vehicles stored. Insurance shall include general liability, commercial vehicle insurance, and worker's compensation insurance, if applicable.
