*<u>Note</u>: Where there are terms of different lengths, the candidates with the highest number of votes will be elected to the longest terms.

Instructions for Candidates

The following forms must be filed with the Office of the Borough Clerk, Borough Administration Building, 103 Third Avenue S., Haines, Alaska. **Filing period is August 1 through August 20**:

Declaration of Candidacy	Office being sought <u>must</u> be identified; specify assembly, school board or planning commission. This form must be notarized. Notaries are available at the Borough Clerk's Office. Questions? Call the Clerk's Office at 766-6402.
Nominating Petition	The candidate must <u>print</u> his/her name in the blank line in the first paragraph, identify the office being sought, and <u>sign</u> the document under the Statement of Candidate section <u>before</u> circulating the petition. The person circulating the petition, whether it is the candidate or someone else, must <u>print</u> their name on the first blank line in the affidavit and <u>sign in the presence of a notary</u> . Signers not registered as voters in the Haines Borough will be disqualified. Signer eligibility will be checked when the completed form is brought in to the Clerk's Office. Please be sure the printed name of each signer is legible. A <u>minimum of ten</u> valid signatures must be obtained for the petition to be successful. It is a good idea to bring your petition in early and to get two or three extra signatures in case a signer must be disqualified.
<u>2024</u> Financial Disclosure Statement (reporting 2023 Income)	<u>ALL CANDIDATES</u> must file this form, except for incumbents who have already filed a 2023 statement. This is a local form required by HBC 2.06.035. The completed form must be submitted with your Declaration of Candidacy. An electronic, fillable version is available on the borough's website. Hard copies are available upon request. Any questions about this form can be directed to the Clerk's Office.
Certification of Submission to Alaska Public Offices Commission (APOC)	<u>ALL CANDIDATES</u> must file a state APOC form. For most of you (not planning to raise/spend more than \$5,000 on your election), you must complete the following form: <u>http://doa.alaska.gov/apoc/forms/candidate_exemption 1</u> <u>0.pdf</u> and return it through the APOC Forms Online Filing System (https://my.alaska.gov/). This form is required by the state and does not need to be submitted to the Clerk's Office. Depending on your particular campaign plans, there may be additional forms to submit. Failure to comply may result in fines by the Alaska Public Offices Commission. Any questions regarding the required campaign form(s) should be directed to APOC at (907) 276-4176 or toll-free (800) 478-4176. <u>Proof of</u> <u>Submission of APOC Forms must be submitted to the Clerk's Office.</u>
Withdrawal Form	This is an optional form to be used only, if needed. If you would like to withdraw from candidacy after being certified as a candidate, the notarized form must be returned by

5:00 pm August 23 to the Clerk's Office.

As long as they remain under the \$5,000 threshold, this is the only form they are required to file with APOC. Although exempt candidates do not file campaign disclosure reports, they are still subject to the laws that apply to candidates, including the requirement that ads, yard signs, and other campaign materials include "paid for by" identifiers as required under AS 15.13.090 and 2 AAC 50.306. If an exempt candidate exceeds \$5,000 in financial activity they must immediately file a Candidate Registration and file each report due after the change in status, disclosing all activity from the beginning of the campaign on their first report. AS 15.13.040(g); 2 AAC 50.286.

OR

For Candidates intending to spend more than \$5,000 on his/her election:

Candidate Registration: Must be filed **within 7 days** after filing the Declaration of Candidacy with the Municipal Clerk's Office. The registration provides your campaign contact information, designates your campaign committee, and your campaign depository. Candidates may amend registrations as needed. **Until a candidate files their registration, designating a Treasurer or Deputy Treasurers, only the candidate may accept/expend campaign funds.**
