

HAINES BOROUGH CLERK REPORT TO CANVASS BOARD (ASSEMBLY)

October 6, 2020 General Municipal Election

Following is a report of the October 6, 2020 Haines Borough Election ballots cast at the polls on election day; the absentee ballots cast by mail (ABM), fax or email (ABF/E) and in person; and questioned ballots. A certain number of ABM, ABF/E, and questioned ballots remain uncounted and must be considered by the Canvass Board. The recommended count is provided in the shaded areas. Reasons for any disqualified ballots are provided, as well.
