I was raised with property valuation being a daily conversation as my step father was an appraiser and my father a land use rights attorney.

I recently appealed my assessment and was satisfied with the result but very disappointed to hear of the struggles my friends and neighbors experienced with their assessments and appeals.

It was clear to me in the process of appeal that we do not have a proper system of valuation or equalization and I am concerned that if not carefully handled by concerned and experienced citizens it will not be able to improve.
