To: Haines Borough Assembly Members and Mayor

Re: Appointments to the Historic Dalton Trail Road Maintenance Service Area

I believe that several appointments to the Historic Dalton Trail Road Maintenance Service Area were made in violation of borough code at the last assembly meeting. Haines Borough Code requires that members of service area boards be "persons from within the service area."

HBC 7.04.080 Boards.

A. The ordinance establishing a service area may provide for appointed or elected boards of **persons from within the service area** to make recommendations concerning services or other purposes, as permitted by statute. For appointed boards, all appointments shall be made according to the provisions of HBC <u>2.60.055</u>. If the assembly determines that an appointed or elected board is not necessary, or if a board lacks the minimum membership required by the ordinance establishing that board, the assembly shall perform the functions of such board.

I requested a copy of all committee/board applications up for confirmation at the January 10 assembly meeting from the Deputy Clerk and received them by email on January 17. There was no letter of interest from Bob Bell. The letter of interest from Robert Venables states that he is "only physically there on an occasional basis for this season." The letter from Darsie Culbeck states that he "would be a good go between" for Constantine and the borough however he isn't "from within the service area." (please see attached letters of interest)

I suggest that the assembly vote in favor of reconsidering the January 10 decision confirming the appointment of Robert Venables and Darsie Culbeck to the Dalton Trail RMSA board and table the motion to confirm until the borough attorney can advise on whether these appointments comply with HBC 7.04.080.

Also, the Haines Borough Application for Board Appointment should be revised to include HBC 7.04.080 which would inform future applicants for RMSA boards of the qualifications for board membership. Perhaps if all the applications had been included in the assembly packet as they usually are, the assembly would have had the information needed when voting on whether to confirm these appointments. Also, borough staff could review applications for RMSA boards for compliance with borough code before they come before the assembly.

Thank you for reconsidering the vote to confirm these appointments in order to ensure compliance with borough code.
