

**AN ORDINANCE OF THE HAINES BOROUGH AMENDING THE PORT OF HAINES  
TERMINAL TARIFF NO. 3 TO SIMPLIFY CALCULATION OF DOCKAGE FEES AT THE  
PORT CHILKOOT DOCK.**

BE IT ORDAINED BY THE HAINES BOROUGH ASSEMBLY:

Section 1. Classification. This ordinance shall not become a part of the Haines Borough Code.

Section 2. Severability. If any provision of this ordinance or any application thereof to any person or circumstance is held to be invalid, the remainder of this ordinance and the application to other persons or circumstances shall not be affected thereby.

Section 3. Effective Date. This ordinance is effective January 1, 2011.

Section 4. Purpose. This ordinance amends the Port of Haines Terminal Tariff No. 3 to simplify calculation of dockage fees at the Port Chilkoot Dock rates at dock facilities.

RULE NO. 34 TERMINAL TARIFFS

300. ITEM 300 DOCKAGE RATES (C)

Dockage charges are assessed upon Length-Over-All (LOA) of the vessel. LOA is defined as the linear distance, in feet, from the most forward point at the stem to the aftermost part of the stern of the vessel, measured parallel to the base of the vessel.

LOA of the vessel as published in "Lloyds Register of Shipping" will be used and when not published, the Port reserved the right to: (a) obtain the LOA from the vessel's register, or (b) measure the vessel.

~~A dockage surcharge will be in effect for vessels utilizing the Port Chilkoot Dock. This surcharge shall be assessed upon Length Over All of the vessel according to the table below and shall be charged in addition to the standard dockage charges.~~

EXCEPTION: Dockage charges shall not apply to vessels under 135 feet Length-Over-All if the vessel's use of the dock is directly associated with a current dock use agreement.




