

**An Ordinance of the Haines Borough amending Haines Borough Code 2.04.040 and 2.06.030D to make non-substantive changes as recommended by the Code Review Commission.**

BE IT ENACTED BY THE HAINES BOROUGH ASSEMBLY:

Section 1. Classification. This ordinance is of a general and permanent nature and the adopted amendment shall become a part of the Haines Borough Code.

Section 2. Severability. If any provision of this ordinance or any application thereof to any person or circumstance is held to be invalid, the remainder of this ordinance and the application to other persons or circumstances shall not be affected thereby.

Section 3. Effective Date. This ordinance is effective upon adoption.

Section 4. Amendment of Title 2.04.040. Section 2.04.040 of the Haines Borough Code is hereby amended, as follows:

**2.04.040 Oaths of office.**

Elected officials, borough officers and other employees as required for the performance of their duties, before taking office, shall affirm in writing that they will honestly, faithfully and impartially perform their duties. The oaths shall be administered by and filed with the clerk or his **the** clerk's designee and shall be substantially in the following form:

I solemnly affirm that I will support the Constitution of the United States, the Constitution of the State of Alaska, and the Charter of the Haines Borough, and that I will faithfully perform the duties of \_\_\_\_\_ to the best of my ability.

Section 5. Amendment of Title 2.06.030D. Section 2.06.030D of the Haines Borough Code is hereby amended, as follows:

**2.06.030 Misuse of official position.**

...

D. For one year after he leaves **leaving** office, an assembly member ~~or school board member~~ elected under the Borough Charter ~~may~~ **shall hold not hold any** compensated borough office or employment that was created, or the salary or benefits of which were specially increased, **in a vote by the assembly** during his **the** last year **the member was** in office ~~by the body of which he was a member~~. **The same rule shall apply to school board members.** This section does not apply to employment by or election to a charter commission.
