NOTICE OF PROPOSED CHANGES TO INTRODUCTION OF SEEDS OR CLONES TO LICENSED PREMISES IN THE REGULATIONS OF THE MARIJUANA CONTROL BOARD

Brief Description: The Marijuana Control Board proposes to change regulations in Title 3, Chapter 306 of the Alaska Administrative Code dealing with the introduction of seeds or clones to licensed premises..

The Marijuana Control Board proposes to make changes dealing with the introduction of seeds or clones to a licensed premises including the following:

3 AAC 306.405(a)(9) is amended to increase the number of clones or cuttings that may be introduced to a licensed premises and to allow any number of seeds to be introduced to a licensed premises.

You may comment on the proposed regulations, including the potential costs to private persons of complying with the proposed regulations, by submitting written comments to Alcohol and Marijuana Control Office at 550 W. 7th Avenue, Suite 1600, Anchorage, Alaska, 99501. The comments must be received not later than 4:30 pm on November 6, 2023.

The questions must be received at least 10 days before the end of the public comment period. The Alcohol and Marijuana Control Office will aggregate its response to substantially similar questions and make the questions and responses available on the Alaska Online Public Notice System and https://www.commerce.alaska.gov/web/amco/
