NOTICE TO THE PUBLIC AND REQUEST FOR INFORMATION LAS 34228 STELLAR ADVENTURE TRAVEL

Subject to AS 38.05.850, the Southeast Regional Land Office previously posted public notice of Stellar Adventure Travel permit application from March 22, 2023 through April 6, 2023. In order to address questions received and updated information provided by the applicant, the Division of Mining, Land and Water (DMLW) is providing the following information for clarification:

Area of Operation: The areas of operation fall within the current heliskiing map approved by the Haines Borough. DMLW would be authorizing moderate use of state land within Units 1 (Kelsall River), 5(Kicking Horse), 6(Chilkat Inlet), & 9(Ferebee River) as required by Special Use Designation ADL 106858 in the Haines State Forest Management Plan. An updated operations map is part of this notice.

Activity: This authorization would be a 5-year Land Use Permit for entry and commercial use of state land within the Haines State Forest for the purpose of guided heliskiing tour operations. DMLW does not authorize helicopter use, flight corridors or landing sites with this permit. Any questions on helicopter use should be directed to the Haines Borough.

Deadline for Comments: May 10, 2023

All comments previously provided during March 22, 2023 through April 6, 2023 will remain part of the record and considered during adjudication of LAS 34228.
