On behalf of the Haines Borough, it is a privilege to recommend the Alaska Arts Confluence (Confluence) for the 2017 Our Town award regarding the Community Design of the Interconnected Portage Cove Waterfront.

For more than a decade, the Confluence has been a stalwart in promoting the arts through local strategic planning and public outreach, creating positive approaches to future growth in our community. The Confluence represents 24 organizations and over 90 individual artists, and its efforts are widely supported by governmental and non-governmental agencies.

Dear National Endowment for the Arts,

The Haines Sheldon Museum strongly supports the Alaska Arts Confluence's Our Town proposal. The proposal will fund a much-needed planning process for our beautiful historic harbor, engaging a diverse cross-section of stakeholders in proactive planning for the 1.6 mile Portage Cove waterfront. Our concern is that the waterfront, which started as a beautiful sandy curve, is being cut up by differing concerns and not being viewed as a whole asset whose aesthetics greatly enhance our town.

The Haines Sheldon Museum is located on a bluff overlooking the Portage Cove waterfront, just above the small boat harbor. Our site is the location of the first settlement in Haines, the Presbyterian missionary home. From our location, we look at the harbor and the striking Lynn Canal – a mountain-lined fjord at the northern end of the Southeast Alaska water corridor. In our collection, we hold photographs showing the harbor over time, as it became more and more built up.

The museum serves as the anchor between the waterfront and Main Street. The museum's sculpture garden, which has grown rapidly since its inception two years ago thanks to generous private donations, helps encourage visitors who are walking along the waterfront to climb up the hill and explore downtown. We hope that as part of the planning process funded by this grant that we will solidify a vision for direct access to our grounds from the waterfront, and from there into downtown.

The Haines Sheldon Museum shares with Arts Confluence a vision of a better quality of life for citizens through the arts. Creative place making is one way we can make this happen. We have worked together with the Arts Confluence on Art on Main Street, co-founded First Friday, and were key in the development of the Sculpture Garden and Fort Seward Interpretive Walking Tour signage.

In small town Alaska, where the winters can be long and dark, creative outlets and inspiration are vital to the mental health and well-being of the community. These creative outlets include visual arts, impromptu performances (in our town these often use beautiful locally made puppets or Native dancing), skits or storytelling. At the museum, we encourage artists to submit for one-man shows, where they reimagine a small gallery. We also have community guest curators who develop an exhibit around their passion, be it puppets or portraits or Native formline art. Art demonstrations in our water front garden also pull people into town.

I hope that you are able to fund the Arts Confluence's request. It will make a significant difference to our community.

Please strongly consider the Alaska Arts Confluence's application for an Our Town Waterfront Planning Grant for Portage Cove, here in Haines, Alaska.

Our waterfront is at a critical crossroads, with a patchwork of recent and planned development promising to alter one of Alaska's great coastal mountain landscapes. Our municipality has been unable to meaningfully plan for this area, although it has made statements in support of trails, beaches and other public improvements.

I have confidence Alaska Arts Confluence could play a critical role in hammering out a community plan for this area acceptable to all interests, given the group's track record of success.

The Arts Confluence has proved itself a quiet engine of progress in our town, steadily helping revitalize Main Street and Fort Seward.

Partnering with businesses, it established storefront art displays and helped with commercial displays to make our commercial thoroughfare attractive. Small-town merchants struggling to survive against Internet sales and big-box stores often lack the time, as well as expertise, to make their businesses attractive.

The Confluence stepped in to help the businesses, and in doing so, helped our town.

The Confluence's "First Friday" program brings as many as 100 or more people downtown on Friday nights, a time slot when our Main Street was most often deserted. These events draw a diversity of residents, providing an important social mixer in our small town and valuable exposure to area artists.

The success of the idea was demonstrated by a number of other stores and attractions (even the Presbyterian Church) opening their doors on Friday nights to be part of the scene.

At historic Fort Seward (conjoined to our downtown), the Arts Confluence sculpture garden has taken a literal junkyard and transformed it into the area's most captivating art installation. The foundation of the demolished barracks for years was a prominent community eyesore. It's now a colorful and intriguing attraction, drawing visitors into the town's history.

The Confluence's Fort Seward interpretive walking tour is an important addition to this privatelyowned historic area, as the most recent attempt at providing on-site interpretive information dated to the mid-1980s.

The Alaska Arts Confluence has demonstrated its ability to work with residents from all parts of our community to move its ideas and projects forward. More importantly, the group has proved it knows "where to go" in our town for resources and individuals who make its projects a success.

These attributes, I believe, make Alaska Arts Confluence a worthy planning grant recipient. To date, money spent by this group has not been wasted.

RE: Our Town proposal from Alaska Arts Confluence to partner with the Haines Borough to plan a interconnected and accessible waterfront

Over the years the waterfront for the Haines Townsite in the Haines Borough has been subjected to private and public development. However, we have not, as a community, solidified a plan that addresses accessibility for all segments of the community – though we intend to, as evident in the Haines Borough Comprehensive Plan officially adopted by the Haines Borough Assembly. I believe that those relevant sections have been or will be provided to you by the applicant for the Our Town grant. I believe that I can speak for the community's "good intentions," having served on the Assembly for 4 years and more recently as Mayor. What we lacked was a champion for the development of a plan from within the community. We needed a committed and visionary community based partner. I believe that the Arts Confluence is that partner and together, with the elected leaders, we can create a waterfront environment that serves all segments of the population.

I would like to speak as loudly as possible on behalf of one of those segments – the elderly and the disabled. For over a decade, I worked as a special education teacher for the Haines School District. I continue to serve out-of-school individuals with special needs; and as a rising elder myself, I am well-aware of the needs of our 80 – 90- and 100 year olds, many of whom served as backbones for this community –but now, due to lack of foresight and planning, are cut off from enjoying our waterfront. I am a proponent of an accessible path that will connect all segments of the waterfront and will provide healthy and beautiful recreation for children, elders, tourists and community members who, though not boat owners, nor cruise ship passengers, take great delight in observing the environment that supports those who are.
